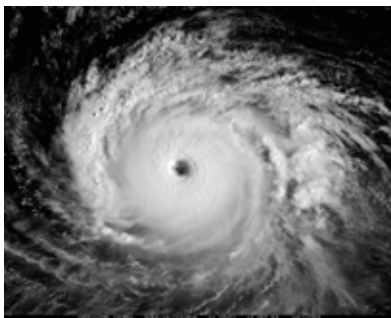

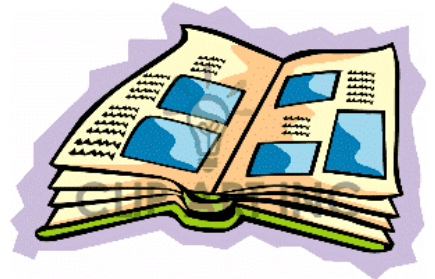

I have worn hearing aids for a number of years, on and off. I say on and off because it has been off more with my most recent pair purchased from another provider in Venice. I had an annoying problem with feedback, which neither they nor another local provider were able to correct or alleviate. Both told me I should consider newer, more advanced models, which they would be happy to sell me. Since mine were similar, I felt they were more interested in making a sale than helping me. As a result, they wound up in my dresser drawer (not an uncommon situation.) I decided to give it one more go. A friend referred me to Blair Post at Contemporary Hearing.

LAPTOP WEBCAM: COVER IT UP

If you have a laptop computer it probably has a webcam built in that you can use with programs like Skype. NSA whistleblower Edward Snowden recommends covering it with a piece of opaque paper when you're not using it. Even Mark Zuckerberg, the CEO of Facebook, follows that advice.

It's a relatively simple process for someone who really wants to gain access to a remote webcam to do it. NSA types can do it. Hackers can do it. Even high school administrators can do it. Just ask Blake Robbins, a Philadelphia-area student who won a \$175,000 lawsuit settlement when Merion School District admitted he had been photographed 400 times in a two-week period, sometimes while he slept in his bedroom, as part of a misguided effort to locate missing school-issued laptops.

You might be wondering, "What about the little red light that comes on whenever the webcam is turned on?" Circumventing that feature is no challenge to hackers. Something else that's not a challenge to them: turning on your laptop's built-in microphone to use as a listen device any time they want to.

VThat's why in addition to covering up the webcam you might also want to use a piece of heavy tape (like electrician's tape) to cover up the microphone opening in the case. (Sometimes there are two of them.)

ARE OTHERS NOT GETTING YOUR E-MAILS?

Do friends or family sometimes tell you they never received an e-mail you sent them? It could be that certain words or special characters triggered a spam filter. Usually a spam filter just puts flagged e-mails into a spam or "junk e-mail" folder. Sometimes, though, an Internet Service Provider's spam filter can actually delete an e-mail proactively and not even deliver it to the person it was sent to.

To reduce non-delivery problems, keep the following in mind while composing your e-mails. Filters are **especially** sensitive to these spam clues in the Subject: line, but they also factor them in when analyzing the body of the e-mail.

Special Characters

- More than one exclamation point (!) or (!!!)
- More than one question mark (??) or (???)
- Sentences (or worse, paragraphs) IN ALL CAPS
- Substituting symbols to obfuscate trigger words (Vi@gra)

Trigger Words

- Targeting a narrow market (Viagra, porn, Oxy)
- Targeting get-rich market (guaranteed winner, prize, lottery)
- General "salesy" spam (free, act now, limited time)
