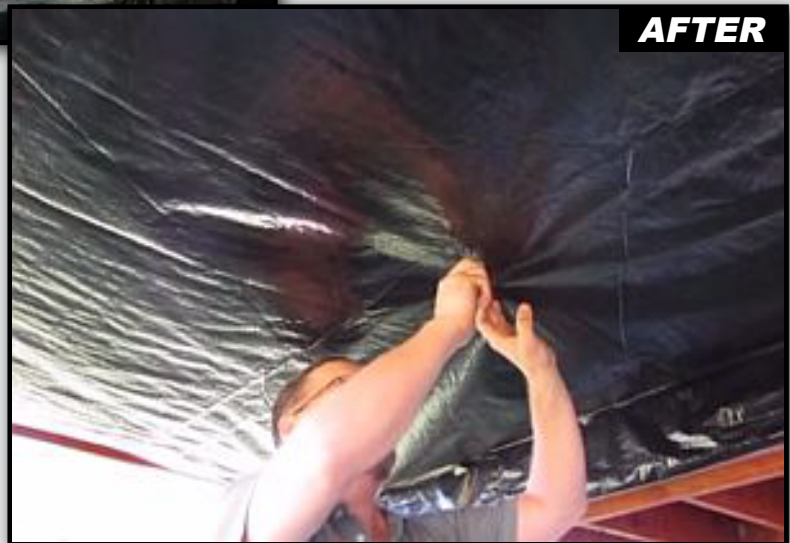

Refreshments are served at 9:00 a.m. and the meeting is called to order at 9:30.

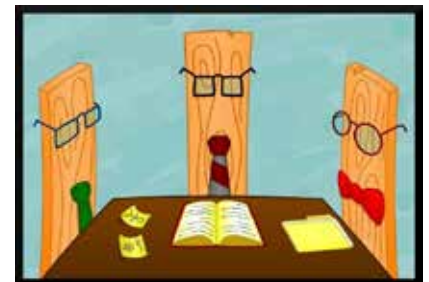
