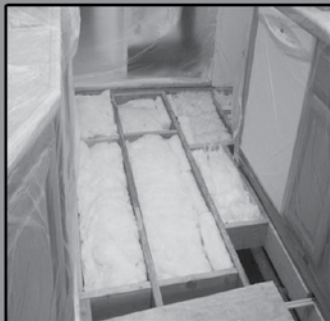

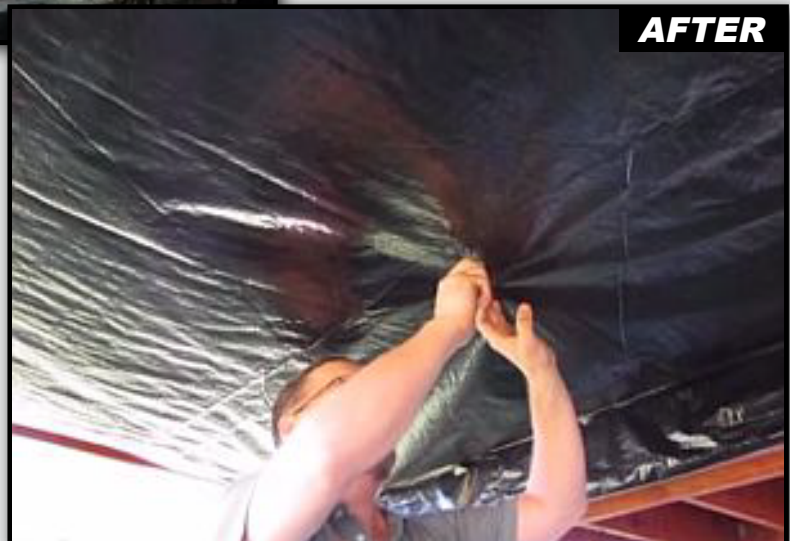

**PARK RULES QUIZ ANSWER**

Watering of lawns is addressed in the prospectus under Rule 8 (MOBILEHOMES, YARDS AND LANDSCAPING), paragraph F, which states:

“No resident may water their lawn except by means of a hand-held watering apparatus, and watering will be the responsibility of each resident on a pre-scheduled basis where sprinkling shut-off valves are provided.”

Many people would argue that there is little useful guidance there.

You may find it far more helpful to know that residents are subject to the watering restrictions of Sarasota county. Those restrictions are reasonably well documented

online and can be found easily with any web search engine such as Google, Bing, or DuckDuckGo.

None of the four watering restriction scenarios is as straight-forward as it might seem.

a) There are no day-of-week or time-of-day watering restrictions for flower beds or gardens.

TRUE—as long as you are hand watering your plants with a hose with a spray nozzle on the end.

b) There are no watering restrictions for the first 60 days for NEW LAWNS – including seed and sod installations.

FALSE—for the first 30 days you may water any day between 4 PM and 10 AM. For the next 30 days you may water up to three days per week during those hours, depending on your address. After that it's a max of two days per week.

c) Hose-end spray nozzles and hose-end oscillating sprinklers are both acceptable watering devices for established (i.e. not new) lawns.

TRUE. The county has no restrictions on lawn watering devices, and Leslee Jones indicates that ELS considers hose-end oscillating sprinklers to meet the prospectus's Rule 8F requirement for a hand-held watering apparatus.

d) In-ground watering systems are acceptable IF pop-up heads are used that will not interfere with lawn mowers.

FALSE. While in-ground watering systems are in place for some common areas, Rule 8F does not allow residents to install in-ground systems to water individual lot lawns.

- a) Leashes may not be more than 10 feet long.
- b) If you don't live in a designated "pet area" you must have a letter from your doctor stating the medical reason you need a service animal and the service(s) it provides you.
- c) When your dog poops you must pick it up and properly dispose it unless the waste is on your own mobile home lot.
- d) When you move into the park with a dog or cat, or get a new one, you must provide the park with documentation of its license and of all required vaccinations. All such licenses, vaccination and records must be kept up to date.
