The Daunting Donut Dilemma

“Saturday Morning Coffee” at the clubhouse is important.

It is the hub of much of the HOA’s informal communications and decision making. Things often get started there, then get communicated and implemented through the formal channels: board and association meetings, our newsletter, the Event Alerts e-mails, etc.

In the summertime, Saturday Morning Coffee attendance gets pretty sparse due to snowbirds’ absences and others’ travel. Consequently, we usually don’t serve donuts during the summer. But the rest of the year the “dash for the donuts” is there on the MC’s agenda. Sometimes it’s called the “run for the buns,” but serving donuts is always a central part of Coffee.

We buy Yummies Donuts (arguably the tastiest in town) and sell them for a buck a piece. That used to be enough to cover our expenses, even though Yummies has always carried a premium price tag. Unfortunately, inflation has gradually impacted the situation greatly.

Today Yummies charges \$1.35 for regular donuts, and \$1.65 for cinnamon buns, fritters, and “blossom”/cake donuts. Additionally, there is a \$5.00 delivery/fuel charge which, depending on the size of our order, adds another \$0.16 to

\$0.26 per donut. That means a donut for which we receive \$1.00 costs us anywhere from \$1.51 to \$1.91.

Which brings us to the Daunting Donut Dilemma.

Saturday Morning Coffee is important to the HOA, and donuts have always been a central part of Coffee... but is continuing to subsidize Saturday Morning Coffee this way what we should do, or should we do something else?

- Continue at \$1.00 but only one Saturday per month
- Stop serving donuts except at association meetings
- Increase the price to actual average cost, maybe \$1.75
- Find a cheaper supplier, and recruit members to take turns doing pickups
- Brainstorm for another more creative solution

What are your thoughts? The board of directors needs to address this dilemma, and we welcome your input. Please let any of the directors know what you think would be the best solution.

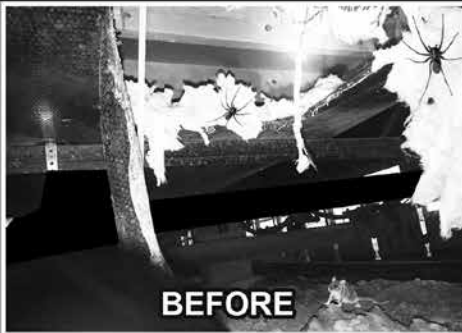
Several people asked me for the recipe for the dish I made for the Women's Luncheon. So here it is.

- 3 c. cooked and cubed chicken
- 3 c. diced celery
- 1 pt. Hellman's mayonnaise
- 1 c. toasted almonds
- 1 t. salt
- 1 t. accent
- 3 T. chopped onion
- 3 T. lemon juice
- 1 c. grated cheddar cheese
- 1 1/2 c. potato chips
- 1/2 t. tarragon

Sprinkle lemon juice over chicken. Combine all ingredients except cheese, potato chips & tarragon. Pile lightly in buttered dish. Sprinkle with cheese and top with potato chips & 1/2 t. tarragon.

Bake at 450 for 20 min. Let stand for 15 min.

KNOW YOUR PARK RULES

Why is each of these statements about pet ownership false?

- a) Leashes may not be more than 10 feet long.
- b) If you don't live in a designated "pet area" you must have a letter from your doctor stating the medical reason you need a service animal and the service(s) it provides you.
- c) When your dog poops you must pick it up and properly dispose of it unless the waste is on your own mobile home lot.
- d) When you move into the park with a dog or cat, or get a new one, you must provide the park with documentation of its license and of all required vaccinations. All such licenses, vaccination and records must be kept up to date.
- e) Licensure and vaccination documentation requirements for guests' pets are the same as for residents' pets.
- f) If you live in the designated pet area, you may have one or two dogs that together may weigh no more than 40 pounds.

Check your knowledge at **Park Rules Quiz Answer** on page 15-16.

The Park Rules are found in the prospectus. The rules lay out what is required of both residents and the park owner. Everyone is given a copy when they move in, and agrees in writing to abide by the rules. Unfortunately, few people read the rules thoroughly. Fewer still review them regularly. As a consequence, the question of "what's allowed" comes up frequently. Providing clarity is the purpose of this monthly article.

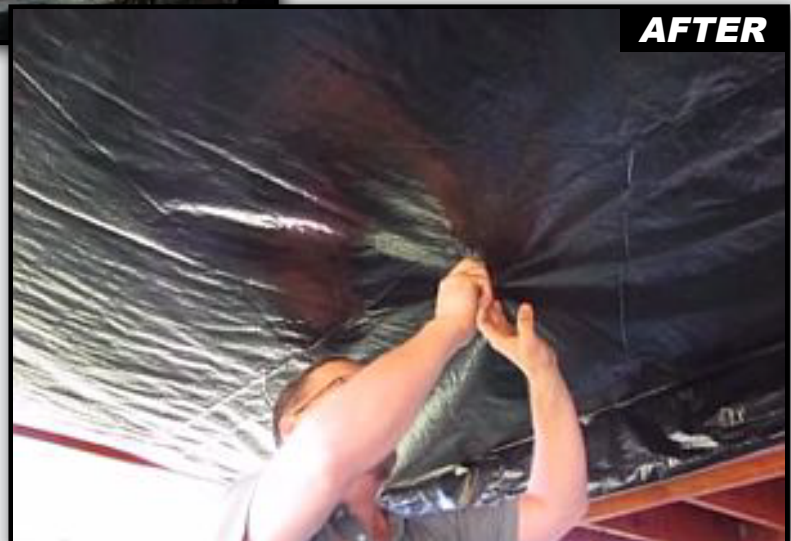

From a strictly financial perspective if none other, our HOA's most important annual event is the rummage sale. Last year its profit represented 25.9% of all our revenue for the year – by far our largest single source of income.

By comparison, our second largest source of income was event ticket sales. The total sales of tickets to all events for the year represented only 18.6% of our revenue for the year.

I am happy to report two very positive pieces of news relative to the 2020 rummage sale. (Yes, the one that's just 4 months away!)

First, we finally have a chairperson! Two of them actually. Our board vice president, Susan Adkins, and our treasurer, Joyce Martin, both agreed to serve as co-chairpersons of the rummage sale. I am confident that their capabilities, enthusiasm and commitment will enable them to make this year's sale another successful one.

At your earliest opportunity please thank them for selflessly taking on this key role.

One of the major things both Susan and Joyce want to achieve is creating a **Rummage Sale Manual** that future chairpersons will find truly useful. Fortunately, the Havens–Van Buskirk co-chairs that brought super success to the 2018 and 2019 sales have already started work on the Manual and have pledged their support to Susan and Joyce.

The second piece of good news is that our inventory of sales items has been growing quite nicely so far. Please be sure to **keep**

the sale in mind between now and mid-February whenever you have household items in good condition that you are ready to get rid of. Strain to Hear?

While presenting to the recent Chamber Expo, a woman stopped by our booth and asked if her dad should get his hearing tested.

I asked, “When does he struggle to hear well?”

She said, “He doesn’t struggle. He hears well but I just thought since he is 86 years-old, he should have it checked.”

I said, “No. I would have his hearing checked if he works to hear you or your family. If he struggles to hear then have his hearing checked.”

- * Does your spouse complain that the TV is too loud?

Does answering yes mean you have a hearing loss? No, these are just indicators. They suggest you should get a hearing test so know your baseline.

After the hearing test when I review your results with you, I will give you tips to hear better during these situations.

There is no fee to have the test.

If your loss could benefit from hearing aids, and you want to, I will let you try a set of hearing aids for one week. There is no contract, no obligation. You can try the aids for one week. At the end of the week, I will ask if you noticed improvement in these four areas.

PARK RULES QUIZ ANSWER

The rules about pets are listed in Section 24 of the Rules and Regulations, contained in the Bay Lake Estates prospectus. (Additionally, the Pool Rules specify that no pets are allowed in the pool area.)

Each of the Quiz statements is **false**.

False: *Leashes may not be more than 10 feet long.*

The pertinent rule is Paragraph F:

“A pet must be accompanied by his owner and on a leash at all times when outside of that owner’s mobile home.”

The statement is false because the rule specifies no particular maximum length.

However, any reasonable interpretation of the rule would focus on the intent of **having the pet under control** at all times. “Under control” would mean being able to prevent the pet from...

- dashing in front of a vehicle or bicycle;
- attacking a person or another pet;
- walking far into another resident’s yard (e.g. going near someone else’s home or flower beds).

Depending on the circumstances, having a pet on even an 8-foot long leash could be non-compliant with the rule.

False: *If you don't live in a designated "pet area" you must have a letter from your doctor stating the medical reason you need a service animal and the service(s) it provides you.*

The relevant rule is Paragraph B:
"A resident living in a designated pet area of the park [...] may own one small (not exceeding 20 pounds) domestic pet..."

This rule was written years before the Americans with Disabilities Act ("ADA") was passed in 1990. The ADA gave certain individuals many rights under federal law, including the right to have service animals go nearly anywhere with them.

Under ADA you may claim the right to have a service animal live with you in Bay Lake in an area **not** designated as a "pet area." ELS is entitled to some level of assurance that you are actually entitled to claim the special rights you are claiming under ADA.

However, ELS may not require that you present medical information about yourself, nor may they require that you explain or document the specific things a support animal would be doing to assist you. Therefore, the statement above is false.

False: *When your dog poops you must pick it up and properly dispose of it unless the waste is on your own mobile home lot.*

The relevant rule is Paragraph E:
"Each pet owner is responsible for removing their pet's bodily wastes from the park property. Failure to do so will be sufficient cause for permanent removal of the pet from the park."

The statement is false because there is no exemption from picking up after your pet even if its waste is on the lot your own home is located on.

If you are a pet owner and a Bay Lake Estates resident, you are expected (and required) to be a responsible pet owner.

Because of the length and complexity of the answers to the pet rules questions, the last three false statements will be explained in next month's Rules Quiz.

False: *When you move into the park with a dog or cat, or get a new one, you must provide the park with documentation of its license and of all required vaccinations. All such licenses, vaccination and records must be kept up to date.*

False: *Licensure and vaccination documentation requirements for guests' pets are the same as for residents' pets.*

False: *If you live in the designated pet area, you may have one or two dogs that together may weigh no more than 40 pounds.*
