Potentially Life-altering Legislation

What kind of impact do you think the following changes to Florida statutes would have on most mobile home owners?

- ♦ Require a buyer of your home to make improvements and/ or repairs specified by the park owner before occupying the home. (The effect is to prohibit as-is sales.)
- ♦ Allow park owners to serve eviction notices by regular mail instead of certified mail – effectively allowing park owners to evict a homeowner without proof that an eviction notice was ever served, removing the right to fight an eviction.
- ♦ Permit park owners to force a new mobile home owner to sign for – and in effect, agree to – an integrated prospectus (including new park rules) which was not approved by the state, not agreed to by the homeowners association, and not approved for the park.

At the time this February issue of The Bay Laker was going to press, the statuses of three legislative bills were in a state of flux. Two of the three contained elements that were very negative to our interests – like the 3 changes highlighted

2020 ELECTION "RESULTS"

Bay Lake Estates HOA elections are held at the March membership meeting each year. However, the names of the members who will


be locked after hours both Thursday and Friday, so plan accordingly.



What I Wish You Knew...

Having worked in this industry for over 20 years, I've seen all too often people who waited to get their hearing checked struggle during conversations. They describe the same pattern, while listening to their friend's story one word sticks out as odd, and they lose track of the rest of the story.

It's always just one word in a story that causes confusion, which results in an interruption since the story doesn't make sense. Needing to ask for help with a misunderstood word gets embarassing for the listener. Overtime they stop asking for clarity. Then they worry that everyone thinks they are always confused.

Being able to hear a story clearly is what hearing aids should do.

People think wearing a hearing aid is like wearing glasses. When you look at a flower, you see a flower. When you hear a simple noise, like a siren, you hear the sound. However, a better comparison would be listening is like reading, since both involve understanding what is being shared.

Reading is not about looking at words it is about comprehension of words. Reading a story requires you to imagine characters and what they will do. When you get caught up in a story you feel their reactions and hope for their future. You have an emotional response to the characters. You aren't just reading words, you engage in what happens.

Listening to a conversation is not about hearing sounds, it is about the words and their meaning. Listening involves the entire story, including emotions and experiences. You honor your friends by engaging with their stories.

Studies have shown that waiting to address a hearing loss will reduce the words you understand. Every time a word is not understood during a story, you will lose the flow of what is being shared while you try to figure out that one word. Missing out on words during a conversation reduces your ability to connect the words you hear to the full experience of the story.

If you get lost when hearing a story and wonder if you hear well enough, call for a hearing test, 941-244-9300.

DOES BUTTER NEED TO BE REFRIGERATED?

The bacteria that causes food poisoning requires a protein-rich environment in order to multiply, which is why you can leave an onion out on the counter overnight but not a steak. Butter is mostly fat. It contains a small amount of water and a very small amount of protein. Not enough to promote significant bacteria growth. This is especially the case with salted butter, since salt inhibits the growth of bacteria. Salted butter will keep for weeks at room temperature.

If you don't go through at least one half stick of butter each week, you're, 1) not cooking right, and, 2) probably not reading this article because you don't care about butter.

Clarified butter is pure butterfat, without the water and milk solids, which means it has a very long shelf life. You could keep clarified butter at room temperature for several months. First, you need to melt a stick or

two of butter, then using a fat separator or a spoon, only remove the clear butter from the top and not the water and milk at the bottom. Or you can refrigerate the melted butter and poke several holes when hardened to disperse the liquids at the bottom.

Spoiled Butter vs. Rancid Butter

Rancidity is caused by exposure to oxygen, light and/or heat. To prevent rancidity, keep one stick or less of butter in an opaque butter dish or purchase a butter keeper like Mrs. Anderson's Ceramic Butter keeper at Bed Bath & Beyond for \$9.99 that will keep your butter for up to 20 days without refrigeration. After all, who enjoys cold, hard butter on warm fluffy pancakes or hot crisp waffles? Do you really enjoy tearing up your bread by trying to spread cold, hard butter on it?

Finally, if you keep your butter dish on or near the stove, or near the toaster, or if it stays above 80 degrees in your kitchen, the shelf life will be shortened. The real issue is rancidity, not bacterial spoilage. Other than direct cross-contamination, there's really no plausible way for butter to make you sick.

DAZN APP ADDED TO X1

We are currently rolling out the DAZN app to Xfinity Internet customers with Xfinity X1 service. DAZN (pronounced "da-zone") is an over-the-top (OTT) subscription service where you can play, pause and rewind over 8,000 live and On Demand sporting events every year, including 70+ exclusive fight nights.

To access the DAZN app, customers can press the **xfinity** button on their remote and navigate to **Apps** > **DAZN**.

AMBIENT MOODS APP ADDED TO THE X1

PARK RULES QUIZ ANSWER

This month's quiz touches on a number of park rules. Let's look at each of them and evaluate if any violations would occur under the hypothetical circumstances.

Rule 1B states in part "All guests must be registered in the park office. No mobile home may be left in the possession of anyone under 18 years of age.

As long as Granddaughter and her friend register upon arrival, there is no violation of rule 1B.

Rule 1C states in part "Each resident is required to acquaint all of their guests with all conditions relating to the use of the park."

You would be violating rule 1C if you only admonished them "to take care of the place and refrain from being rowdy." The rule requires you to explain all the pertinent park rules to them, and to make sure they understand and agree to abide by them.

According to rule 1E, "Minor children or grandchildren of residents may visit four weeks out of any calendar year. Use of any facilities of the park by such minors shall be governed by the rules pertaining thereto, and conditioned on such minor being accompanied by an adult at all times."

Since neither Granddaughter nor her friend is a minor, rule 1E does not pertain. Therefore, they are covered by another part of rule 1B:

Guests, whose stay does not exceed 30 days in any calendar year, are also not charged [an additional fee]. No other occupant shall be


allowed, except with the express permission, in writing, from park owner.

The main consequence is that if Granddaughter stays "4 weeks" (i.e. 28 days) with her best friend, and she comes back in the same calendar year to visit with you here, she can stay only 2 more days without breaking the rule unless you get permission from the park owner.

Rule 2C states "No resident shall permit anyone to use their mobile home in his, her or their absence without prior written approval from park owner and unless the use is for longer than fourteen (14) days. Anyone receiving such approval shall sign and abide by the park's Rules and Regulations."

However, rule 2 covers "renting and use of mobile home." Since Granddaughter is not being charged rent, rule 2C does not seem to apply, although on its own the rule's applicability appears ambiguous.


One final point is worth noting. While there is no rule that would require you to notify Leslee in advance of your granddaughter staying during your absence, providing such notification would, firstly, be common courtesy, and secondly, would promote better security for everyone involved.


