A special segment aired on the History Channel this past July 11th regarding the Colosseum in Rome. The Colosseum is the largest



ancient amphitheater ever built, and is still the largest standing amphitheater in the world today, despite its age. Built around 60-70 A.D., the emperor at that time was former General Titus who oversaw this magnificent construction project, the first of its kind in the entire world.

The Colosseum was the symbol of *conquest* and authority for all of Rome to admire. Gladiators from around the known world flocked to Rome just to participate in the 123 days of continuous games. Many would not return home after meeting their fate on the field. The Roman citizens loved the action as well as the ability to provide a thumbs up (to save their favorite gladiator from death) or a thumbs down (to watch him die a gladiator's death). Years later, the Colosseum housed dozens of flesh-eating lions, when Christians were thrown to the lions for sport. Some years later, Emperor Commodus fought on the field as a gladiator. He was a Roman emperor who ruled from 176 to 192 A.D. He served jointly with his father Marcus Aurelius from 176 A.D. until the latter's death in 180 A.D.



WWE RAW airs on Monday nights, on USA. Whenever I see the *trailer* for WWE RAW, the indoor stadium is filled with

blood-thirsty followers. Though I'm not fan of wrestling or cage fighting, this event does remind me of the same blood-thirsty crowd from the days of the Roman Colosseum. Saturday, <u>December 31st</u> at 6:00 p.m., BLE will host a Pot Luck Dinner for all residents to enjoy.




There will be a sign-up sheet so folks can see what other people are bringing in order to avoid having too many like-kind food items i.e., desserts, salads,

I would also like to thank Andy and Donna Takach for asking me often what I needed as they rode by on their golf carts a few times a day. They offered room in their freezer so I could salvage some meat that was still frozen. (It was strange how the electricity in the park was sporadic and scattered.) They let me charge my phone and even use their microwave. It had been quite a while without a decent meal, so it was very much appreciated. Many of us went without electricity for over 6 days, the restaurants and gas stations were closed for miles from either damage, no power or simply out of gas or supplies.

So, we couldn't drive far to find a restaurant. We also had a boil water notice. Hard to boil water in the hurricane aftermath without power.

The week of cool and dry days that followed the hurricane had to be heaven sent. So, I thank God for that. I don't know how we would have managed the long hard days of cleaning, clearing and hunting down ice, water and gas if we also had to deal with sweltering temperatures and rain. The nights may have been very dark and long, but they were cool, as we slept through the haunting sounds of twisted metal blowing in the night wind through our opened windows.

I will never forget the look on everyone's face during that week. A look of shock, exhaustion, trauma, and bewilderment.

As the news of horrific stories of all those in Fort Myers began to trickle in, our hearts sank even further and we felt lucky. Lucky? Yes, most of us were lucky in comparison.

My heart goes out to our own neighbors that completely lost their homes here. It truly looked like a war zone on every street here and the damage seemed quite random.

After a few exhausting days waiting for the power to come on (Don't hold me to the number of days. It was all a blur.), I decided I truly needed a warm shower, a decent meal and a safe place to sleep. I drove to the Ramada Inn only to find out that they were completely full. I ran into Carol Gilchrist in the lobby. She was staying one more night. She took one look at me and offered me her room. They would go home and I could stay there if I couldn't find a hotel.

With no cell service in the lobby, I returned to my car to make some unsuccessful calls to other hotels. By that time, the only energy I had left was from the heartwarming boost Carol gave me with her generous offer had dissipated. Instead, I drove back to my dark home and jumped in bed with my cats. We were home. We were safe and tomorrow would be another day. Thank you, Carol, from the bottom of my heart!

<u>MY FAVORITE EASY RECIPE</u>

CHICKEN & DUMPLINGS (6-8 SERVINGS)

1 Whole Chicken (GreenWise @ Publix) + 1 or 2 boxes of no-sodium chicken broth,

1 lg onion (chopped), 12oz bag peeled baby carrots, 1 stalk celery (1/2 chopped & ½ whole stalks) several Bay Leaves, no-sodium salt, white or black pepper, celery seed, jar of *Better Than Boullian* chicken base. 1 box of frozen Anne's flat Dumplings (Publix).

Place whole chicken in a large pot. Add water (about 2/3 of a pot); add onions carrots & celery, salt, pepper, bay leaves & celery seed. Cook on medium low heat until chicken is cooked and meat is falling off the bone (1.5 - 2 hrs). Once cooked, remove chicken and wait for it to cool down before de-boning with fingers.

Add chicken bones and skin back into the pot. Add 2-3 tsp of the chicken base. Cook this about 2 hrs., or less. Using a wire mesh strainer, gradually empty the pot into a 2nd pot. Using tongs, remove and save the carrots & only the celery stalks.

Cut up the chicken into small pieces and save. Set some of the cooked chicken aside for a sandwich. Slice up the celery stalks and cut the carrots in half or in thirds and save.

Add the strained broth. Add the box of broth and bring to a soft boil.

For the dumplings, rather than scratch made, follow the instructions on the boxed dumplings. The I dumplings are scored -3 to a sheet. DO NOT COOK the entire box.

Using a clean pot, melt ½ stick of butter, then add enough flour and stir until smooth, not thick like paste. I Add the broth, kick up the heat and whip over medium heat until thickened. When the sauce/gravy is to I your liking then add the chicken, vegetables & cooked flat dumplings. When I boiled my dumplings in I the broth, they cooked for 8-10 minutes and I removed them as I went, then added this to the pot as a I final step.

The unit also exists to aid residents "in time of sickness, death or any other adversi-ty." Bill Wiagness, current director of the program, said

that so far the medical unit has not been put into use, but a natural disaster has yet to happen.






