This is the same old-fashioned recipe which required constant stirring in a black iron skillet. Stir only 4 times when microwaving.

POWER LEVEL: High

MICROWAVE TIME: 8 to 11 min., total

Microwave at High 4 Min-

utes.

1 cup roasted, salted ... Stir in peanuts. Micropeanuts wave at High 3 to 5 Min-

wave at High 3 to 5 Minutes, until light brown.

1 teaspoon butter

...Add butter and vanilla to syrup, blending well. Microwave at High 1 to 2 Minutes more. Peanuts will be lightly browned and

Pour mixture onto lightly greased cookie sheet, or unbuttered non-stick coated cookie sheet. Let cool ½ to 1 hour. When cool, break into small pieces and store in airtight container.

NOTE: If raw peanuts are used add, before microwaving, to the sugar-syrup mixture, along with 1/8 teaspoon salt.

MIRACLES DO HAPPEN

For this issue of the Bay Laker, I'm combining The Humane Thing To Do with Miracles Do Happen. There is much detail to this true story.

I titled this article, **The Injustice – Justice System.**

A little background... In 2014 I stumbled across a news article on MSN concerning the release of 2 men, after being incarcerated for over 31 years who sat on death-row for the rape and heinous murder of 11 year-old Sabrina Buie, neither man committed. They are Henry McCollum and his half brother Leon Brown (yes, you can google their name). After performing an extensive research regarding the details of this murder I wrote a 3 page summary for a Documentary, titled, "Shades of Black and White" I planned to present to both men as an example of my writing along with a cash deposit of \$25,000 for the exclusive rights to their story. Since I had a contact at SHOWTIME I felt this story would make a great documentary. Years later, as it turns out, this "wrongful conviction" story did appear on a HLN special, along with other wrongful conviction stories, during a special segment aired only on HLN.

So, I took it upon myself and drove to Red Springs, North Carolina from Savannah, GA on a Saturday morning, the week the two men were released from prison, with hopes of locating the two men. When I arrived in Red Springs, I stopped at several churches, then a few restaurants and soon thereafter I did locate an address for the brothers. By the time I found them it was too late. Showtime beat me to it by just an hour or so and had locked up their exclusive story with a \$50,000 cashiers check.

THE STORY... In 1983 both men, African American's, 19 and 14 years of age at the time of their arrest, were accused and subsequently convicted by a *very famous* D.A. in Robeson County, for the rape and heinous crime of murdering eleven year old Sabrina Buie. They were both sentenced to death. I am not going to divulge details of the murder. Too gory.

Recently discovered DNA evidence brought to the attention of those in authority by the *Innocence Inquiry Commission*, proved to be enough to free the two men after serving nearly 31 years for a crime they have always shared with anyone who would listen that they did not commit.

The evidence box, that reportedly <u>did not exist</u>, or was <u>told</u> to investigators was certainly <u>lost</u>, was discovered by the Inquiry Commission at the Red Springs Police Department. The box contained Sabrina Buie's fingernails, hair samplings, a cigarette butt and three beer cans all found at the Buie crime scene in 1983. The DNA and fingerprints belonged to a man named Roscoe Artis. Artis, staying with his sister in Red Springs, sports a lengthy history of crime. He was no doubt dodging a 1980 warrant for his arrest for the rape and murder of a Gastonia County, NC, woman. Artis lived 100 yards from the very soybean field where Buie's body was discovered.

Just <u>one month</u> before McCollum and Brown went to trial, Robeson County district attorney Joe Freeman Britt convicted Artis for a crime similar to that of Buie. Artis admitted to having murdered 19 year old Joann Brockman. He also led police to where her clothes and other evidence were secretly hidden. Artis received the death penalty. It was an easy victory for Britt.

The coincidence of facts in this case were such that when Artis went to prison he befriended McCollum and Brown. He was also heard telling others that

McCollum and Brown did not kill Sabrina Buie. Artis knew the truth. Now we also know the truth. Former district attorney of Robeson County, Joe Freeman Britt, a Native American, dubbed 'The Deadliest D.A.' in a live interview on a 60 Minutes TV segment brags about having convicted well over 40 defendants to death row. In 1976 his record of convictions was entered into the Guinness's Book of Records and was updated in 1988 with having 47 death row convictions.

An egotistical Britt acquired two additional feathers in his cap (no pun intended) when he tried and convicted McCollum and Brown to death row, based solely upon a very shaky signed confession by two very scared young boys with an IQ bordering retardation (IQ tested in the 60's). Other than the detailed signed confessions, Britt offered no hard evidence during the trial. The convictions were based solely on two signed confessions.

The confessions, we later learn, was hand written by an SBI agent (State Bureau of Investigation) who was present at the Buie crime scene, the autopsy and the interrogation of McCollum and Brown.

A second murder took place in Red Springs within one month of the Buie murder in 1983. Nineteen year old Joann Brockman was found raped and murdered in like fashion as Sabrina Buie, yet district attorney Britt <u>failed to associate</u> the two murders as being committed by the same person. The fact that he refused to acknowledge or investigate the possibility of both murders being committed by the same person strongly suggests his motive was only to rack up two more death row inmates. After all, he had a reputation and a conviction record to uphold. Several days prior to the McCollum trial the Red Springs police did suggest to the SBI that the beer cans found at the Buie crime scene be sent out for fingerprints. Nothing came of that request.

It wasn't until 2010 (27 years later) when a cellmate of Leon Brown suggested he send a letter to the Innocence Inquiry Commission and formerly request that DNA be tested from the evidence gathered at the crime scene.

On Wednesday, September 3, 2014, Superior Court Judge Douglas Sasser ruled to set the two men free. The judge ruled that DNA testing of a cigarette butt found at the scene pointed to another man.

The "miracle" in this story is two-fold: Despite the underhanded crookedness of a D.A. bent on convicting innocent people just to rack up more points, after 31 long years of torture and suffering in prison, two innocent men were finally released thanks to the evidence box that was preserved by the Red Springs Police Dept and the Innocence Inquiry Commission for their efforts in freeing the brothers. This short article is for lovers of beef, pork and seafood.

My guests, Scott & Kelley, from Michigan, who hope to live in Bay Lake Estates one day, love to go out to eat as often as possible when visiting. And, why not, we do have an abundance of eateries close to us. They chose PRIME STEAKHOUSE in Venice for our Friday evening meal. After looking at the menu on-line I could NOT resist trying PRIME myself.

Scott, a staunch lover of a good rib-eye steak, discovered all of PRIME'S steaks are dry-aged

for 28 days. Although he elected NOT to order the dry rubbed rib-eye he did order the regular rib-eye steak and he claimed it was the very best rib-eye, ever - perfectly cooked medium and juicy. I consider Scott to be a connoisseur of fine food, since he finds numerous,



very interesting, restaurants to dine at in Charleston, Savannah, New Orleans, Sarasota, etc.

Kelley, on the other hand, a serious pork-chop lover, ordered this awesome looking, double boned, pork chop (see photo), char cooked to perfection. The pork-chop was a beautiful presentation of the kind of food items PRIME serves.

I was anxious to try the pan seared Red Snapper with citrus crust and orange beurre blanc (whatever that is), along with a side of roasted garlic and parmesan mashed potatoes. I was NOT disappointed. Simply yummy. And, for an appetizer I ordered their French Onion Soup which, being a former Chef, I have always loved a tasty bowl of French Onion Soup. Absolutely delicious is the only way I can describe this soup.

Overall, the three of us gave PRIME **two**, **very big**, **thumbs up**.

The cool thing about dining at PRIME is a house salad is *included* with your meal, which is mixed and served table-side (and they leave the bowl in case you want more salad), along with one side dish of your choosing. Nothing is ala-carte, including a basket of pop-overs served with butter early on. Service (our server was James) and the food was fantastic. Try it yourself, but <u>don't</u> tell them Michael sent you simply because they don't know me, yet.






