As summer comes to a close, Snowbirds (including me) are already starting to think about heading south again to be with our winter friends. I'm really looking forward to seeing you all this fall. Until then, here's a bit of news:

RENT INCREASE:

The rent increase notice (effective January 1, 2024) was to be mailed around September 19th. Most of you should have received it by now. This official notice is what triggers our negotiation process with ELS. Please rest assured that your Rent Negotiations Committee is ready for the task and will do everything they can to ensure get the most reasonable rate. It is important to note that park owners are not obligated to meet with our homeowners' committee to negotiate. They have always been receptive to working with us in the past, and we hope to continue this practice and achieve the best possible results, especially this year, since so many are still struggling with the financial burden of expensive repairs in the wake of Hurricane Ian. Stay tuned for updates!

COMCAST CABLE:

Our contract with Comcast for our cable package also expires this year. Leslee has been working on this for a couple months already, looking at alternative solutions, researching what other parks have and what they pay for cable. For example, Bay Indies does not have a contract with any cable provider and each owner is responsible for their own cable package. We all know how expensive these individual packages can be! I must admit, I was very surprised at the low cost of our cable package when we first purchased a home in BLE, compared to our Canadian

102 MINUTES THAT CHANGED AMERICA

On Sunday, September 10th, immediately following a long drawn-out football game, which I was forced to watch the exciting ending, 60 Minutes aired a 9/11 special that was very different from any other 9/11 documentary I had ever seen in the past. This special presentation was filmed so well I plan to watch it again by going to <https://www.cbsnews.com/60-minutes>.



It was definitely heart wrenching to watch this show and learn that the FDNY firefighters who approached the Twin Towers that dreadful day were under orders to rescue those inside the towers. They laid down their life knowing in advance before entering the towers they may not survive. Not one firefighter refused to enter the burning tower. This demonstration of raw courage speaks for itself. Out of 750 firefighters who went into the towers that day 343 did not survive. This, to me, was the ultimate sacrifice.

Later, during that segment, we meet the adult

children of certain firefighters who joined the FDNY as a result of that day's tragedy and the sacrifice their dads made to save people. Many children were only 8 – 10 years old at the time.

On Monday evening, September 11, 2023 the History Channel aired several back-to-back documentaries that were filmed and aired long ago following the 9/11 terrorist attack. These also were heart wrenching simply because we re-live the moment all over again: The plane slamming into the building, the smoke and fire coming from the South Tower; we then see the 2nd plane crashing into the North Tower; the smoke and fire; then the eventual collapse of the South Tower which caused folks everywhere to panic. To watch all over again the 2nd tower collapse was an emotional moment for many. But what was most interesting was listening to the wide variety of opinions from people as to what happened that dreadful morning. Some folks thought perhaps a bomb was planted in the building and exploded while others believed a missile struck the tower. It was all speculation until the 2nd plane struck the North Tower. What was also very interesting to me was people from all walks of life and races came together as 'one' and helped each other through those tough moments. Folks were sobbing like babies; people hugging complete strangers brought tears to my eyes. The title "102 Minutes That Changed America" was the title the History Channel assigned to the documentaries that aired on 09/11/2023. I saved the PEOPLE Magazine 22 years ago (I scanned just the cover) just for this moment to share with you. This photo will forever remain in my mind and my heart.

DECEIPT, FRAUD, SCAMMERS

A recent buyer in our park shared this story with me. She purchased a home on Flamboyant St. and at the last minute she had concerns that perhaps all her floors needed replacing and believed that perhaps the problem originated in the crawl space from moisture or standing water that may have caused moisture damage to the floors in certain spots.

It turns out that she hired an advertiser to look under her home, which they did obliging so. They took photos of the crawl area and shared those photos with her. Upon reviewing those photos she freaked out and tried to back out of her purchase.

She then hired someone else to get inside the crawl space and he did. He also took photos and the crawl area **did not look** like the same crawl area as in the first group of photos supplied from that company. In fact I was told this was the cleanest crawl area he had ever seen. Perfect condition. No names mentioned, intentionally.

On another note, I recently hired an HVAC company to inspect my AC (done annually) and it appeared I needed to replace the blower module (\$850), which was replaced 2 years ago with another company. It appears the parts were made by a certain brand that we may think is reliable, because of the name. The parts were inferior to other brands. One shouldn't have to replace the blower module more than once. The new company I used DID NOT charge me that day for the service call or the parts simply because I opted to purchase a brand new AC unit from them. The moral to this story is you need to know with whom you're doing business with. It's not easy to find an honest or reputable company but when you do, keep that number in your phone.

Struggle to Hear?

While presenting at the recent Chamber Expo, a woman stopped by our booth and asked if her dad should get his hearing tested.

Does answering yes mean you have a hearing loss? No, these are just indicators. They suggest you should get a hearing test so know your baseline.

After the hearing test when I review your results with you, I will give you tips to hear better during these situations.

There is no fee to have the test.

If your loss could benefit from hearing aids, and you want to, I will let you try a set of hearing aids for one week. There is no contract and no obligation. You can try the aids for one week in your everyday life.

MY FAVORITE EASY RECIPE

One of my favorite go-to meals is lamb chops on the grill. Simple, easy and quick.

Make sure you purchase the RIB CHOPS from Publix and not the lamb chops shaped like a small porterhouse steak. The rib chops are carved from the rack of lamb and are very tender chops.

You can either marinade the chops in olive oil/lemon juice, oregano, salt & pepper or just lightly sprinkle no-sodium salt, freshly ground black pepper and CAVENDER'S Greek Seasoning on both sides. Let the chops sit on a plate at least one hour before broiling on the grill. Any side dish or veggie will suffice. TRAVIS MILLS

Retired United States Army Staff Sergeant Travis Mills of the 82nd Airborne is a recalibrated warrior, motivational speaker, actor, author and an advocate for veterans



and amputees. Travis's New York Times bestselling memoir, "Tough as They Come", is currently available on sale in bookstores everywhere. Despite losing portions of **both arms and legs** from an IED while on active duty in Afghanistan, Travis continues to overcome life's challenges, breaking physical barriers and defying odds. Travis lives by his motto: "*Never give up. Never quit.*"

On April 10, 2012, United States Army Staff Sergeant Travis Mills of the 82nd Airborne was critically injured on his *third tour of duty* in Afghanistan by an IED (improvised explosive device) while on patrol, losing portions of both legs and both arms. He is one of only five quadruple amputees from the wars in Iraq and Afghanistan to survive his injuries.

Thanks to his amazing strength, courage, and incredible will to live, the heroic actions of the men in his unit, the prayers of thousands, and all the healthcare providers at the Walter Reed Army Medical Center, near Washington D.C., Travis remains on the road to recovery. Every day is a battle, but Travis continues to astound friends and family alike with his progress and with his amazing spirit to survive.

In September 2013, Travis and his wife, Kelsey, founded the Travis Mills Foundation, a nonprofit organization, formed to benefit and assist post 9/11 veterans who have been injured in active duty or as a result of their service to our nation. The veteran and their families receive an all-inclusive, all-expenses paid, barrier-free vacation to Maine where they participate in adaptive activities, bond with other

veteran families, and enjoy much-needed rest and relaxation in Maine's great outdoors.

The Travis Mills Group LLC was started shortly after, where Travis consults with and speaks to companies and organizations nationwide inspiring all to overcome life's challenges and adversity.

Travis's story has been featured on local and national news including Fox News' Happening Now with Jenna Lee, The O'Reilly Factor with Bill O'Reilly, CNN with Barbara Starr, and The Ellen DeGeneres Show.

Arizona girl found safe in Montana after disappearing in 2019, PD says. GLENDALE, Ariz.



- An Arizona teenager who disappeared days before her 15th birthday nearly four years ago is safe after walking into a police station in Montana, authorities announced Wednesday, July 26, 2023

Alicia, now 18, showed up alone this week about 40 miles from the Canadian border and identified herself to authorities there as the missing teenager, according to police.

Navarro, who was described as a high-functioning *autistic* teen, left her home in the middle of the night over three years ago on Sept. 15. She was 14 at the time of her disappearance.

"She showed up to a police department, and identified herself as Alicia Navarro, and she basically asked for help to clear her off of a missing juvenile list. She, by all accounts went on her own free will, she is not in any kind of trouble, she's not facing any kind of charges she is not being held anywhere. She is coming and going at her own free will and she has been extremely cooperative not only with our folks

but our federal partners as well," Santiago said.
